To be used only in the manufacture of a rodenticide registered under the PEST CONTROL PRODUCTS ACT.

**PRECAUTIONS:**

1. KEEP AWAY FROM CHILDREN , PETS, DOMESTIC ANIMAL, WILDLIFE AND PREVENT ACCESS BY UNAUTHORIZED
2. FOR USE ONLY BY AUTHORIZED RODENTICIDE MANUFACTURERS OR PERSONS FULLY EXPERIENCE IN PREPARING BAITS FOR RODENT

3. WEAR RUBBER GLOVES, VAPOUR MASK, GOGGLES AND PROTECTIVE CLOTHING WHEN HANDLING CONCENTRATE.
4. WEAR RUBBER GLOVES WHEN HANDLING BAITS AND AVOID CONTACT WITH THE SKIN.
5. WASH CONCENTRATE FROM THE SKIN OR EYES IMMEDIATELY. WASH HANDS BEFORE EATING, DRINKING, SMOKING OR AFTER WORK.
6. STORE IN ORIGINAL CONTAINER, TIGHTLY CLOSED, LOCKED IN A SAFE DARK PLACE.

**TOXICOLOGICAL INFORMATION:**

EPIBLOC ® RODENTICIDE TECHNICAL CONCENTRATE is a toxicant-sterilant for Norway and Black rats. A single feeding results in acute poisoning or male sterility, depending on the amount of poison consumed. Sterilant properties are species specific and no secondary toxicity due to the eating of baited rats by non-target species is known. Testing in many mammals, including primates, showed temporary infertility, but no permanent sterility, even at doses that were eventually lethal. Symptoms of human poisoning include: nausea, giddiness, vomiting, quick pulse, and dyspnoea. Treat symptomatically.

**STORAGE:**

Do not contaminate water, food or feed by storage or disposal. Storage: Keep in original container in a cool, dry, well-ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.
