DIRECTIONS FOR USE:

SHAKE WELL BEFORE USING - HOLD CONTAINER UPRIGHT - APPLY IN SHORT BURSTS

FLYING INSECTS: Close doors and windows. Direct mist upwards to all parts of the room especially windows and other light sources. Apply 3-5 second bursts in 30 m³ of space. Whenever possible keep doors and windows shut for 15 minutes after each treatment. Also direct mist into areas where insects are present.

CRAWLING INSECTS: Spray hiding places such as baseboard, moist areas, openings around sinks, drains, and pipes, behind cabinets and storage areas. Spray ant trails around door sills, window frames, and in ant nests. Insects must be contacted to be killed.

Ensure proper ventilation after sealed areas have been treated.

PRECAUTIONS: Do not use in the presence of open flame or spark. Contents under pressure. Do not puncture or incinerate. Container may explode if heated. Do not allow temperatures of container or contents exceed 50°C. Harmful if swallowed or absorbed through skin. Avoid breathing vapours or spray mist. Avoid contact with skin and eyes. KEEP OUT OF REACH OF CHILDREN.

Do not apply directly to food or utensils. In commercial food processing plants and food service establishments, apply only when plant is NOT in operation. Cover or remove all food and food processing equipment during application. In space spraying in food processing plants, meat-packing plants, bakeries and other food processing plants, thoroughly clean all equipment, benches, shelving, etc. where exposed food will be handled, with potable water before resuming operation.

Remove pets, birds, and cover fish aquariums before spraying.

Do not use in nurseries or rooms where infants, ill or aged persons are confined.

FIRST AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. If irritation persists, seek medical attention. If poisoning occurs, get prompt medical attention or call a Poison Control Centre.
