FOR USE WITH ROUND-UP(R) WITH MINIMUM OR ZERO-TILLAGE SYSTEMS

For control of Green Foxtail (setaria viridis), Wild Oats (avena factual), Mustard (brassica kaber) and Volunteer Cereals. Apply 350 mL of TWEEN(R) 20 with 1.1 litres of ROUND-UP(R) in not more than 100 litres of clean water per hectare.
