This insecticide is designed for use in the automatic mister dispenser (actuator) which releases 27.5 mg of K.O. formula every 7.5 minutes. The continuous use of this insecticide will reduce the flying insect populations-the effect should be noticeable within a few hours. Each can contains enough product to protect a room of 170 cu. m for up to 30 days.

DIRECTIONS: Remove protective cap from the top of can and insert can in special automatic dispenser. Place dispenser / actuator 2-3 metres above floor at point where air circulation will carry

particles through the area.

USE AREAS: Restaurants, Food Plants, Dairies, Stables, Cow Barns, Poultry Houses, Ski lodges, Summer Lodges, and Resorts and other areas with at least 170 cu. m of free flow air space where flies, mosquitoes and gnats are an annoyance.

CAUTION:

In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food processing.
