USE RESTRICTIONS:

Materials treated with Rodewod should not come into contact with food, food holding containers, food storage areas or food growing buildings.

DIRECTIONS FOR USE:

Use Rodewod Technical material to formulate wood preservatives and products intended for sapstain control on lumber. Use only for the manufacture of non-food use pesticide formulations

registered under the Pest Control Products Act.

PRECAUTIONS: for formulating use only.

Wear impermeable gloves, protective clothing and goggles. Wear an appropriate cartridge respirator when formulating with this product. Avoid inhalation of chemical dust. May be fatal if swallowed. Harmful if absorbed through skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling and before eating and smoking. Avoid contamination of food and feed and domestic or irrigation water supplies, lakes, streams and ponds. Do not reuse container, destroy when empty. Rodewod is considered moderately toxic to fish. Care should be taken to provide adequate containment in the use area to prevent the product from entering bodies of water.

FIRST AID:

If swallowed, give 1 or 2 glasses of water and induce vomiting by placing finger in back of throat. Never give anything by mouth to an unconscious person.

In case of skin or eye contact, immediately flush eyes or skin with plenty of water. Get medical attention if irritation persists.

TOXICOLOGICAL INFORMATION:

No specific antidote known. Treat symptomatically.
