**DIRECTIONS:**

FOR USE ON	TO CONTROL	RATE	APPLICATION/ TIMING
Roses and Ornamentals	Mildew and Black Spot	Apply 3 mL per litre of water. Spray to thoroughly cover all plant surfaces.  NOTE: 1 teaspoon = 5 mL	Apply when first sign of disease appears in the spring and repeat every 7-10 days as necessary to prevent infection. If weather conditions favour disease development, spraying may have to be continued throughout the entire growing season. If infection has become established, repeat every 7 days and then reduce application timing to 7 - 10 days to prevent re-infection.

**COMBINATIONS WITH INSECTICIDES:**

GREEN CROSS RosePride™ Funginex\* may be mixed with GREEN CROSS Malathion 500 EC, Diazinon Garden and Fruit Tree Spray or Liquid Sevin. Follow directions on specific labels for insect control. Use mixtures only when disease and insects are both present.

**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid contact with skin and eyes. Causes eye damage. Wear protective glasses when handling. Do not inhale spray mist. POTENTIAL SKIN SENSITIZER. Wash thoroughly after use. Do not contaminate food, feed or bodies of water. This product contains a petroleum distillate which is moderately to highly toxic to aquatic organisms.
