GENERAL INFORMATION

Pfizer Liquid Vegetation Killer is for use in controlling mixed weed and grass growth. Rapid contact action kills most emerged vegetation with bromacil providing extended control of many annual and perennial species. Degree of control and duration of effect will vary with soil type, rainfall and species present; repeat applications may be needed.

IMPORTANT

Partial or complete non-productivity (sterility) of soil may result. Pfizer Liquid Vegetation Killer should not be used on areas where planting of trees, shrubs, grass or crop is planned.

Do NOT apply Pfizer Liquid Vegetation Killer on or near desirable trees, or shrubs or on areas where their roots may extend. Do NOT use on or adjacent to lawns. Do NOT contaminate domestic waters.

DIRECTIONS FOR USE

To control most weeds on non-cropland areas such as railroad and pipeline right-of-way, tank farms, lumberyards, storage areas, industrial plant sites.

Apply Pfizer Liquid Vegetation Killer as annual spray at the rate of 500 to 700 litres/ha. (Apply 6 to 10 litres / 100 m²) Use the low rate on clay or dark coloured soils of high organic matter content.

To control patches of harder-to-kill weeds (such as field bindweed, Canada thistle, horsetail) repeat applications may be necessary.

PRECAUTION

May irritate eyes, nose, throat and skin. Avoid breathing spray mist. Avoid contact with skin, eyes and clothing. Keep out of reach of children.

FIRST AID

If in eyes, flush immediately with plenty of clean water for at least 15 minutes and get medical attention. If on skin, wash with plenty of soap and water.

DISPOSAL

Crush and bury empty container. Bury empty bag.
