DIRECTIONS FOR USE:

For General Cleaning: Mix fifteen (15) mL of SAVOPINE to one litre of warm water for mopping, scrubbing, cleaning and sprinkling floors, walls, and cellars in office buildings, restaurants, mills, schools, etc.

For Disinfecting: Mix twelve (12) mL of SAVOPINE to one litre of warm water and apply to the previously cleaned surface.

Allow surface to remain wet for 10 minutes, then remove excess liquid. Prepare a fresh solution for each use.

Sinks and Wash Basins: Scrub above and beneath units with a solution of fifteen(15) mL of SAVOPINE to one litre of warm water. Then wash out with the same solution, pouring the remainder into the drain pipe.

Toilets and Urinals: The seat and floor around the toilets and urinals should be scrubbed regularly with a solution of fifteen(15) mL of SAVOPINE to one liter of warm water.

Garbage Cans: As a deodorant, thoroughly soak with a SAVOPINE solution, fifteen (15)mL to one liter of warm water. Rinse the empty can with some of the solution and leave the wash in the can.

SAVOPINE when tested by the A.O.A.C. method, is guaranteed to have a phenol coefficient of 5.0 against Salmonella typhosa and Staphylococcus aureus.

IMPORTANT:

To make a satisfactory emulsion, always use fresh, tepid water. Pour required quantity of SAVOPINE into the vessel first, then add tepid water and mix well.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. HARMFUL IF SWALLOWED

May cause skin and eye irritation. Avoid contact with eyes and skin. In case of contact, flush with plenty of water. If irritation persists, get medical attention.

Care should be taken to avoid contamination of food. Equipment disinfected with SAVOPINE should be rinsed with potable (drinking) water prior to use.

FIRST AID INSTRUCTIONS:

If accidentally swallowed, give large quantities of milk, beaten egg whites or flour and water. Do not induce vomiting. Call a physician or poison control centre immediately.

DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to the treatment site. 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. 3. Make the empty container unsuitable for further use.

4. Dispose the container in accordance with provincial requirements. 5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the Manufacturer.
