**DIRECTIONS:** Co-op Garden Insect Dust controls common insects found in gardens, vegetables and vine crops. For best results, dust on leaf surfaces as soon as insects appear. Can be applied anytime.

Asparagus	Beetles	Apply before and during cutting season
Cabbage, Cauliflower and similar crops	Aphids, Flea Beetles	Apply a light layer of dust as soon as insects appear. Repeat as needed.
Tomatoes	Flea Beetles Hornworms	“
Peas	Aphids	“
Cucumbers Melons, and similar crops	Beetles, Squash Bugs	“
Sweet Corn	Corn Borers	“
Potatoes	Potato Beetles	“

Also controls – Bertha Army-worm, Ants, Beet Webworm (incorrectly called Armyworm), Blister Beetles, Currant Caterpillar, Flea Beetles, Raspberry Mite, Turnip Beetle, Box Elder Bug, Tent Caterpillars, Spruce Sawfly and many other common garden insects.

**PRECAUTIONS:** KEEP OUT OF THE REACH OF CHILDREN. Keep this container away from excessive heat, strong light, moisture and free alkali. Keep container closed when not in use. Do not store near steam pipe or radiators. Rotenone is toxic to fish and aquatic life. Do not contaminate streams, lakes or ponds.

**FIRST AID:**

1. In case of poisoning call a physician or contact a poison control centre immediately.
2. If on skin, remove contaminated clothing and wash skin thoroughly with soap and water.
3. If in eyes, flush with water immediately and continue for 5-10 minutes. Get medical attention or contact a poison control centre.
4. If swallowed, induce vomiting then take patient to nearest hospital or doctor's office or contact a poison control centre. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** Do not reuse empty container. Wrap empty container and discard in household garbage.
