## DIRECTIONS FOR USE:

Horses: When used as directed, it provides a protective hair coating against horn flies, house flies, stable flies, horse flies, deer flies, mosquitoes and biting midges.

TO WIPE ON: Brush horse's hair before application to remove excess dirt and dust. Moisten a soft cloth with AQUAGUARD and briskly run cloth over the hair. It is best to apply by rubbing against the hair growth. Give special attention to the legs, shanks, shoulders, neck and area around face where flies generally are seen. Once applied, do not wet skin. Apply 80-100 mL on mature horses and 25-50 mL on ponies. Repeat daily or as required. Do not allow solution to contact animal's eyes, mouth or any wounds.

USE AS A SPRAY: May be applied directly to the horse as a fine mist spray. Spray horses once daily applying just enough spray to wet the hair ends. Apply 80-100 mL on horses and 25-50 mL on ponies. Do not spray on face of animal (wipe on face). Do not cover horses after treatment.

Dogs and Cats: Spray entire body beginning at tail and working towards the head. Do not spray face, eyes or genitals. As you spray, fluff the hair so the spray will penetrate to the skin but spray only until hair is damp, not wet. Spray ticks directly. Spray infected areas such as pets bed and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames, and localized areas of floor covering where these pests may be present. Remove old bedding after treatment. Insects must be contacted to be killed. Repeat as necessary. Do not use on nursing females or on puppies or kittens under 8 weeks of age.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Not for use on humans. Avoid spraying in eyes. Avoid breathing spray mist. Avoid contact with skin. Wash hands thoroughly after use. Vacate room after treatment and ventilate before reoccupying. Do not contaminate feed or water troughs. Do not use on sick animals or animals under drug or pesticide treatment. Before use on pregnant animals, consult a veterinarian. This product is toxic to fish. Do not apply directly to lakes, ponds, streams, tidal marshes or estuaries. Do not contaminate water by cleaning of equipment or disposal of waste. Store in cool, dry area. Do not use or store near heat or open flames.

FIRST AID: If inhaled: Remove affected person to fresh air. Apply artificial respiration if indicated. If in eyes: Flush with plenty of water. Contact a physician if irritation persists. If on skin: Wash affected areas immediately with soap and water. Get medical attention if irritation persists. If accidently swallowed, obtain medical attention or contact poison control centre at once.

DISPOSAL: Do not reuse container. Wrap and dispose of empty container with household garbage.
