DIRECTIONS FOR USE

For use in dairies, dairy farms, milking parlors, milk rooms, horse stables, swine and cattle barns, poultry houses and hatcheries, kennels, and other structures or buildings housing livestock.

Dilute by adding 22 parts of water per 1 part of concentrate. Use only at diluted levels. Shake well before diluting.

For Use Through Automatic Overhead Spraying Systems

To protect livestock from houseflies, horn flies, stable flies, horse flies, mosquitoes, and gnats: Start flow of water into the tank, add concentrate to obtain desired dilution, and agitate well while adding remainder of water. Dispense diluted tank mix through automatic overhead spray system. Locate nozzles to cover a maximum of 200 cubic meters

of space per nozzle. Set timer to operate in accordance with equipment directions and insect behaviour patterns.

For Use Through Handheld Mechanical Foggers

To control houseflies, horn flies, stable flies, horse flies, mosquitoes, and gnats: Dilute with water as above. Apply as a fine mist or fog. Direct spray at an upward angle distributing it uniformly throughout the entire area at a rate of 60 grams per 100 cubic meters of space. For best results, close doors and windows before spraying, and keep closed for 15 to twenty minutes after spraying. Ventilate the area before reoccupying. Repeat application as necessary.

PRECAUTIONS: Keep out of reach of children. Avoid contact with eyes or skin. In case of contact, immediately flush eyes or skin with water. Wear goggles or safety glasses and rubber gloves while mixing. Wash thoroughly with soap and water after handling. Remove any contaminated clothing and wash before reuse. Do not apply directly to feed, water, or feed supplements. Wash teats of dairy animals before milking. This product is toxic to fish. Keep out of lakes, streams, or ponds. Do not contaminate water by cleaning of equipment or disposal of waste.

FIRST AID: If on skin, wash thoroughly with soap and water. If in eyes, flush with clean water. If irritation persists, obtain medical attention. If swallowed, obtain medical attention or contact poison control center at once. Do not induce vomiting because of aspiration hazard. This product contains petroleum distillates.
