3. FOR POOL WATER HAVING VISIBLE ALGAE, SUPERCHLORINATE FOLLOWING LABEL INSTRUCTIONS OF SUPERCHLORINATION PRODUCT EMPLOYED AND WAIT FOR AT LEAST 24 HOURS BEFORE ADDING WEEKLY MAINTENANCE DOSAGE.
4. FOR VISIBLE ALGAE, WHEN SUPERCHLORINATION IS NOT EMPLOYED, ADD 1,000 mL (1L) OF ALGAECIDE 5% PER 10,000 L.
