PYRONIDE 5 PLUS, a ready-to-use insecticide can be applied as a surface or space spray to control flies, tobacco moths, tobacco beetles, Indian meal moths, flour and grain beetles, grain and rice weevils, cockroaches, spiders and silverfish.

DIRECTIONS:

As a space spray application should be carried out at weekly intervals depending upon the rate of infestation. Apply PYRONIDE 5 Plus at a rate of 100-200 mL per 100 m<sup>3</sup> with a machine that produces an aerosol mist. When using a thermal fog generator, apply no more than 320 mL/m<sup>3</sup>. Close all doors and windows and shut off all ventilating systems. Direct spray upwards to all

parts of room, especially windows, lights sources and other areas where insects are present. Spray only when temperature is less than 32'C. Keep area sealed for at least 30 minutes. DO NOT remain in treated area. Ventilate building for at least 30 minutes before re-entering. Follow ventilation, clean up dead insects.

AS A SURFACE SPRAY, apply at an even rate of 5 L/100 m<sup>2</sup>. Apply spray into all cracks, crevices, and hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas.

Spray must contact insects for control.

Note: Keep product away from fire, open flame, lighted electric bulbs, and other sources of heat. Do not use this oil based spray on tiled floor surfaces or rubber backed rugs. Do not spray varnished or plastic surfaces. Do not spray within 1 metre of fabric. Toxic to fish. Avoid contamination of food, feed and water supplies.

IN FOOD PROCESSING PLANTS AND FOOD SERVICE ESTABLISHMENTS, apply only when plant is NOT in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operation. FOR MEAT PACKING PLANTS, treat only when plant is NOT in operation. No exposed meat products, ingredients or packaging materials to be kept in the room. Cover food handling equipment. All treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after treatment and before re-use for food processing.

#### PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN AND ANIMALS. Harmful if swallowed, inhaled or absorbed through skin. Avoid inhalation of spray. Wear mask or respirator when applying spray mist. Wear protective clothing. Avoid contact with skin, eyes and clothing. Wash thoroughly with soap and water after use. PRODUCT CONTAINS PETROLEUM DISTILLATE. Do not store, pour, or use near open flame.

#### FIRST AID:

For skin contact, wash with soap and water. If in eyes, flush

with plenty of water for at least 15 minutes. DANGER: THIS PRODUCT CONTAINS PETROLEUM DISTILLATES. If swallowed, DO NOT induce vomiting. If patient is unconscious give him air. Obtain medical attention immediately.

TOXICOLOGICAL INFORMATION:

Treatment for the various reactions is symptomatic.

DISPOSAL:

Empty contents of container thoroughly into the spray tank. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the emptied container unsuitable for further use. Dispose of the container in accordance with provincial requirements.
