DIRECTIONS FOR USE

To be used in the manufacture of insecticides which are registered under the Pest control Products Act. This product is designed for use at the rate of 3.75% (wt.) with approved diluents or propellents to produce a liquid or pressurized insecticide. This product is not for consumer use.
