At its recommended use dilution, MULTI-SAN yields 564 ppm active germicide providing excellent bacteriological control. MULTI-SAN is non-corrosive to aluminum, stainless steel, and copper surfaces, and contains natural deodorizing properties.

DIRECTIONS FOR USE:

Poultry Houses

1. Remove all poultry and feeds from premises, trucks, coops, crates.
2. Remove all litter and droppings from floors, walls, and surfaces of facilities occupied or traversed by poultry.
3. Empty all troughs, racks, and other feeding and watering appliances.
4. Saturate surfaces with a solution containing 625 mL MULTI-SAN in 100 L (564 ppm) water.
5. Ventilate buildings, coops and other closed spaces. Do not house poultry or employ equipment until treatment has been absorbed or dried.
6. All treated feed racks, mangers, troughs, automatic feeders, fountains, and waterers must be thoroughly rinsed with potable water prior to re-use.

Poultry Drinking Water

For treatment of poultry drinking water add 111 mL of MULTI-SAN in 100 L of water (100 ppm).

Hog Barn Sanitation

1. Thoroughly clean all surfaces (remove all manure, litter, etc.)

2. Spray, soak or fog pens, foot baths, floors, ceilings with a solution containing 625 mL MULTI-SAN in 100 L (564 ppm) water.
3. Equipment such as feeders, waterers, farrowing pens should be thoroughly scrubbed or soaked.
4. For udder washing, wipe with a 625 mL/100 L (564 ppm) solution of MULTI-SAN.

Dairy Sanitation

All non milking equipment should be soaked or rinsed in a 625 mL/100 solution of MULTI-SAN. Permit equipment to dry and avoid contamination. Spray, soak or fog previously cleaned stalls, floors and ceilings with a 625 mL/100 (564 ppm) solution of MULTI-SAN.

Avoid contamination of food. Danger - Corrosive to the eyes. Avoid contact with undiluted product. Keep out of reach of children.

FIRST AID INSTRUCTIONS

For contact with eyes, flush with running water for at least 10 minutes and obtain prompt medical attention. For contact of concentrate with skin, flush with running water for 5 minutes. If swallowed, do not induce vomiting. Call physician immediately.
