DIRECTIONS FOR USE:

TO CONTROL HOUSE MICE, NORWAY RAT, AND ROOF RAT: Place the bait in locations frequented by rodents, such as tunnels, feeding areas, and runways. For rats, set out piles of 15-60 grams at intervals of 2-3 meters. Replace bait which becomes damp or moldy. Maintain an uninterrupted supply until feeding ceases.

NOTE: In food processing plants and kitchens, place bait in protected bait stations on the floor only; do not place in

overhead locations. Wash thoroughly any tables, cutting blocks, or equipment accidentally contaminated. Do not apply bait during production hours or near open foodstuffs.
