DIRECTIONS FOR USE

For use in non-food areas such as dwellings, offices, hospitals, hotels, motels and schools.

This concentrate should be diluted with water before use, at a rate of 1 part concentrate to 9 parts water. The diluted spray should be applied in conventional mechanical or compressed air spraying or fogging equipment. It is not recommended for use in thermal generating equipment. To control ants, centipedes, cockroaches, earwigs, crickets, silverfish, sowbugs and spiders: Apply as a coarse droplet spay directed into cracks, crevices and other hiding places along baseboards, around the base of machinery and under pallets. Treat all returned bottle cartons and cases. Spray thoroughly contacting insects directly whenever possible. Spray badly infested areas daily. In other areas, repeat treatments twice weekly or when reinfestation occurs.

To control flies, gnats, mosquitoes and small flying moths: Close doors and windows and shut off ventilating systems. Apply as a fog or fine mist directing the spray toward the upper portions of the room and towards windows and other light sources which attract these insects. Thoroughly fill the area with mist using 50 to 100 mL per 100 cubic meters of space. Keep area closed for at least 10 minutes. Vacate after treatment and ventilate before reoccupying. Repeat treatment as needed.

On ornamental Plants: This concentrate should be diluted with water before use, at a rate of 1 part concentrate to 79 parts water (12 mL per liter or 1/2 liter per 40 liters). The diluted spray should be applied in conventional mechanical or compressed air spraying or fogging equipment. It is not recommended for use in thermal generating equipment.

To control aphids, two-spotted spider mites and white flies (adults) on ornamental house and garden plants as listed :

Apply as a fog or fine mist, spraying plants with a sweeping motion so that the mist drifts into the plants. Direct spray so that the upper and lower portions of leaves are contacted. Use caution on new growth and tender foliage. When using outdoors, spray when air is still. Repeat as necessary. To control cankerworms, garden webworms, tent caterpillars and the above pests on ornamental crabapple, cherries and plum trees, spray as above. Do not spray on bearing fruit trees.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Exposed foods should be removed or covered during treatment. All food preparation surfaces should be covered during treatment or thoroughly cleaned before using. Wash all contaminated clothing with soap and hot water before reuse. Remove pets, birds and cover fish aquariums before spraying.
