INDUSTRIAL LIQUID SLIMICIDE

TO PREVENT ALGAE, SLIME AND FUNGI IN RECIRCULATING COOLING WATER,

EVAPORATIVE CONDENSERS AND AIR WASHERS.

DIRECTIONS FOR USE: COOLING TOWERS: Formula 3481 is recommended for the removal of slime from fouled towers, add .036 to 1.0 kg of Formula 3481 as supplied per 10 tonnes of water in the system (equivalent to about .5 to 13 ppm active ingredient). This dosage should be repeated 2 to 3 times per week until fouling has been reduced to an acceptable level thus establishing microbial control. Formula 3481 should be added to the basin, to the distribution boxes, or at any point where it will be rapidly and uniformly dispersed throughout the system. **AIR WASHERS:** Add to the air washer sump or chilled water sump to insure uniform mixing. Add 0.45 to 1.16 kg of Formula 3481 (equivalent to 4 to 10 ppm of active ingredient) per 10,000 litres of water in the system, depending upon the severity of contamination to control bacteria, fungi and algae which cause fouling in industrial air washers systems. Badly fouled systems must be cleaned before initial treatment. **NOTE:** For use only in industrial air washing systems that maintain effective mist eliminating components.

PRECAUTIONS: May cause allergic skin reaction. Danger, corrosive to eyes and causes skin burns. May be harmful if inhaled. May be fatal if swallowed or absorbed through the skin. Do not get in eyes, on skin, on clothing. Wear goggles or face shield and rubber gloves when handling. Avoid breathing vapour or mist. Do not take internally. Wash thoroughly after handling. Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. If plastic, do NOT reuse empty container.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife. Treated affluent should not be discharged where it will drain into lakes, streams or ponds or public water. DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to the spray mixture in the tank.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Dispose of the container in accordance with provincial requirements.
4. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the regional office of Environmental Protection, Environment Canada.
5. For small spills. Recover free liquid. Soak up residue with solids absorbent. DO NOT FLUSH INTO SURFACE STREAMS. INFORM ENVIRONMENT CANADA AS IN #4.

PROHIBITIONS: The product as supplied evolves gas (largely carbon dioxide) slowly. To prevent build-up of pressure the product is packaged in specially vented containers. Keep this product in the original container when not in use. Container must be stored and transported in an upright position to prevent spilling the contents through the vent.

FIRST AID INSTRUCTIONS - IF IN EYES: Immediately flush with plenty of water for at least 15 minutes. Get immediate medical attention. IF ON SKIN: Immediately wash with plenty of soap and water. Remove and wash contaminated clothing before reuse. IF SWALLOWED: DO NOT INDUCE VOMITING. Drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Seek medical attention with urgency. IF INHALED: Remove immediately to fresh air. If not breathing apply artificial respiration. If breathing is difficult, give oxygen. Call a physician.
