**DESCRIPTION:**

Germicide liquid algaecide to control pool water algae or to disinfect non-porous surfaces such as showers and indoor pool decks against most harmful bacteria and germs. Acting also as an organic odors killer.

**DIRECTION FOR POOL ALGAECIDE:**

1. Initial dosage for pool water having no visible algae is 120 mL of GERM-AWAY GERMICIDE per 10,000 L of pool water.
2. Weekly maintenance dosage is 60 mL of GERM-AWAY GERMICIDE per 10,000 L of pool water.
3. For pool water having visible algae, superchlorinate following label instructions of superchlorination agent used and wait at least 24 hours before adding weekly maintenance dosage.
4. For visible algae, when superchlorination is not employed, add 300 mL of GERM-AWAY GERMICIDE per 10,000 L of pool water.

**DIRECTIONS TO DISINFECT NON-POROUS HARD SURFACES, SHOWERS AND INDOOR POOL DECKS:**

**Against *Trichophyton mentagrophytes* (causative agent of athlete's foot disease) and to destroy bacteria.**

1. Use prepared solution of 5 mL/L of water. Do not mix with soap or anionic detergent.
2. Apply on pre-cleaned surfaces. Use a mop, sponge or cloth to disinfect.
3. Allow surface to remain wet for 10 minutes, then remove excess liquid.
4. Prepare a fresh solution for each use.

**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN. Corrosive to eyes and skin. Harmful if swallowed. Do not mix with any other chemical. Rinse container thoroughly before discarding. Do not reuse.

**FIRST AID:**

If splashed in eyes or on skin, flush thoroughly with water for 15 minutes. For eye contact, get medical attention. If swallowed, drink 2 or 3 glasses of milk or water. Call a physician or poison control centre IMMEDIATELY. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**DISPOSAL:**

For information on the disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill and for clean-up of spills.

**TOXICOLOGICAL INFORMATION:**
