Apply at bud burst and at 7 - 14 day intervals throughout the season. On apples and cherries, do not use within 7 days of harvest, on peaches within 21 days of harvest.

APPLES: Controls - codling moth, red-banded leaf roller, spider mites, tent caterpillars, apple scab, bitter rot.

CHERRIES: Controls - aphids, red-banded leaf roller, brown rot, blossom blight.

PEACHES: Controls - Oriental fruit moth, spider mites, aphids, brown rot, blossom blight.

SHADE TREES AND SHRUBS, FLOWERS AND ORNAMENTALS - GENERAL

Spray thoroughly both upper and lower leaf surfaces. Apply when plants begin to grow and at 7 - 14 day intervals or as needed.

SHADE TREES AND SHRUBS: Spray for control of spider mites, elm leaf miners, soft brown scale, black scale crawlers, oyster shell scale, cankerworms, tent caterpillars, leaf roller caterpillars, etc.

FLOWERS AND ORNAMENTALS: Spray for control of aphids, thrips, leaf hoppers, flea beetles, mealy bug, spittle bugs, plant bugs, cankerworms, white flies and black spot on roses.
