DIRECTIONS FOR USE:

To be used only in the manufacture of products registered under the PEST CONTROL PRODUCTS ACT. Read Technical Bulletin for formulation details.

PRECAUTIONS:

Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes and clothing. Do not contaminate food, feed or water supplies. This product is harmful to birds, fish and wildlife. Care must be taken to exclude moisture. When drums are opened for inspection or use, they must be tightly resealed.

FIRST AID:

In case of poisoning, call a doctor immediately.

If on skin, remove contaminated clothing immediately. Wash skin thoroughly with soap and water.

If in eyes, immediately splash eyes repeatedly with plenty of clean water or eye wash solution. Obtain medical attention immediately.

If swallowed, give large quantities of water and induce vomiting. Never give anything by mouth to an unconscious or convulsive person. Artificial respiration may be required. Obtain medical attention immediately.

Diazinon is a cholinesterase inhibitor. If cholinergic symptoms occur, give atropine as an antidote. Obtain medical attention immediately.

DISPOSAL AND DECONTAMINATION:

Do not re-use container for any use other than refilling with this product. To dispose of containers, crush, break or puncture empty containers and bury, or deliver them to sanitary land fill dumps in accordance with municipal requirements. If the container is to be refilled, do not rinse with any material or introduce any pesticide other than Basudin 50%. Before refilling, inspect thoroughly for damage such as cracks, punctures, bulges, dents, abrasions, and damaged or worn threads on closure devices. Check for leaks after filling and before transportation. Do not refill or transport damaged or leaking containers. For information on disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the Manufacturer.

STORAGE:

Store in original container in a well ventilated, cool, dry, and secure area. Ship and store away from food, feed or seed. Keep containers tightly closed.
