DIRECTIONS:

For ground or air application. Add water to spray tank until 1/2 full. Add MCPA K 400 then complete filling with water and mix thoroughly. Treat weeds when small for best results and least cost. Use 100-240 litres of water per hectare unless otherwise specified.

HEMP-NETTLE (Suppression only) CROP: Wheat, Oats, Flax, Barley

RATE OF PRODUCT PER HECTARE: 2 L/hectare (800 g active per hectare) 20 litres treats 10 hectares.*

TIME OF APPLICATION: Wheat, Oats, Barley, 3 to 6 leaf stage. Treat when Hemp Nettle is in 3-4 leaf stage. Flax 5 to 10 cm

high. Use at least 100 litres water per hectare on Flax.

CANADA THISTLE (Top growth suppression only) CROP: Wheat, Oats, Flax, Barley

RATE OF PRODUCT PER HECTARE: 1.75-2 L/hectare (700-800 g active per hectare). 20 litres treats 10-11.5 hectares.*

TIME OF APPLICATION: Wheat, Oats, Barley, 3 to 6 leaf stage. Flax - 5 to 10 cm high. Use at least 100 litres water per hectare on Flax.

GENERAL WEED CONTROL (Weeds normally susceptible to MCPA) CROP: Wheat, Oats, Flax, Barley

RATE OF PRODUCT PER HECTARE: 1.5-1.75 litres/hectare (600-700 g active per hectare) 20 litres treats 11.5-13.3 hectares.*

TIME OF APPLICATION: Wheat, Oats, Barley, 3 to 6 leaf stage. Flax - 5 to 10 cm high. Use at least 100 litres water per hectare on Flax.

HARD-TO-KILL WEEDS (Plus general Weed control) - Buckwheat, Smartweeds, Corn Spurry, Hemps Nettle, Canada Thistle (top growth), Russian Thistle, etc.
