FIRST AID

HUMANS: IF IN EYES, flush with clean water for 15 minutes. If irritation persists, obtain medical attention.

IF SWALLOWED, obtain medical attention or contact Poison Control Centre IMMEDIATELY. Do NOT induce vomiting unless directed to do so by qualified medical personnel.

PETS: Harmful if swallowed or inhaled. May irritate eyes, nose and throat. Avoid direct spray of dog's or cat's mouth, face, eyes and genitals. Sensitivities may occur after using ANY pesticide for pets. If signs of sensitivity occur, bathe the pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN.

For HUMANS: Harmful if swallowed, inhaled or absorbed through skin. May irritate eyes, nose, and throat. Avoid contact with mouth, eyes, skin and clothing. Wear rubber gloves during application of this product. Avoid breathing fumes or vapours. Avoid product contact with food, food utensils or places where food is prepared or stored. Avoid contact with pets until dry. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water.

For PETS: Do NOT spray animal's face, eyes, or genitals. Wash hands after using. Do not treat nursing females.

Contents under pressure. Do NOT place in hot water or near radiators, stoves or other sources of heat. Do NOT puncture or incinerate container even when empty. Do NOT store at a room temperature over 50 degrees Celsius.

Toxic to fish and other aquatic life. Cover fish aquaria in the vicinity of treatment area. Toxic to birds.

DIRECTIONS FOR USE

DIRECTLY ON PETS: Use only in well-ventilated areas, preferably outdoors. Do not use on animals under eight weeks of age. Hold container upright while spraying. Wet animal's head with water to drive pests onto the body. Remove cap. Hold can in upright position about 25 - 30 cm from pet. Apply evenly to lightly dampen coat, while protecting animal's eyes from spray, beginning at the tail and working towards the head. Pay special attention to neck, hindquarters, areas under legs, around the tail and between toes. Do NOT spray animal's face, eyes or genitals. As you spray, fluff the hair of the pet. Only spray until the hair is damp-not wet. Apply as evenly as possible because fleas will migrate to untreated areas (e.g., toes, foot pads, around ears). Comb and brush into coat. Spray ticks directly. Do not treat animals more often than once a week. Consult a veterinarian before using on sick, aged, pregnant or nursing animals or animals receiving drug or other pesticide treatment.

For effective flea and tick control, treatment of the pet should be combined with sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required. A veterinarian should be consulted when pest infestation continues to be a problem on the pet. Use ONLY in well-ventilated areas, preferably outdoors.

ON PREMISES:

To control Fleas and Brown Dog Ticks on premises: Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and door frames, and localized areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. Concurrent treatment of animals is recommended. Repeat as needed.

DISPOSAL

Dispose of empty container by replacing cap, wrapping container in several layers of newspaper and placing in household garbage.
