A dual purpose chemical combining fungicidal and herbicidal properties. Controls diseases such as grey and pink Snow Mould. Brown Patch, Dollar Spot and weeds such as Crabgrass.

DIRECTIONS FOR USE: Grey Snow Mould, Typhula Spp: Pink Snow Mould, Fusarium nivale: Apply 75 mL per 100 metre sq. (8.5 Litre per hectare) in sufficient water for adequate coverage. Apply in late fall after danger of heavy rains is past, but before snow covers the ground. Repeat during midwinter thaws when turf is exposed.

Brown Patch and Dollar Spot: Apply 60 mL per 100 metre sq. (7 Litre per hectare) in sufficient water for adequate coverage. Make applications at 10 to 14 day intervals starting in mid-June.

Crabgrass: Use 75 mL per 100 metre sq. in sufficient water (25 to 45 Litres) for good coverage. Make first application in Mid-June and repeat at 7-10 day intervals until mid-August. If weather is hot (over 23 0 C) increase volume of water used to prevent turf injury. Repeat applications are required because of the extended germination periods of Crabgrass. NOTE: Grasses cut to 0.5 cm are more susceptible to injury by PMAS and therefore, on greens and closely mowed turf use 40 mL per 100 metre sq. making 5 to 6 applications at 10-14 day intervals.

CAUTION: Injury may occur on Merion Bluegrass. Do not spray in extremely hot weather. Grass may be injured if temporarily, but off-colour will disappear in 10-12 days. Water and fertilize brown or off-coloured areas. Do not leave PMAS turf fungicide in metal containers for long periods. Phenyl-mercuric compounds are corrosive to metals. Flush the sprayer thoroughly with clean water after day's work.

Do not use in aluminum spray tanks or where part of equipment in contact with solution is aluminum.

WARNING: Keep out of reach of children. Toxic if swallowed, inhaled or absorbed through the skin or clothing. Avoid breathing spray mist.

FIRST AID: In case of contact wash skin with soap and water. For eyes flush with water for 15 minutes and get medical attention.

TOXICOLOGICAL INFORMATION: If swallowed induce vomiting. Call a physician in the event of burning or blistering treat as chemical burn after washing. Do not use oils or greases. Call a physician.
