DIRECTIONS FOR USE: Do not use as a space spray. Do not apply to rugs, carpets, draperies, wallpaper or similar materials that may be stained. Apply with caution to surfaces outlines and avoid excessive wetting. Good sanitary practices should be maintained to prevent re-infestation.

For Cockroaches, Ants, Spiders, Silverfish, Crickets: Spray areas where these pests are found or may hide, including dark corners or rooms and closets, cracks, crevices, along baseboards, and door sills and frames, behind and beneath sinks, stoves, refrigerators, cabinets and frames, and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding should be sprayed directly. Treat ant trails, nests and points of entry. Repeat treatment if reinfestation occurs.

For Carpet Beetles: Spray edges of carpeting and under carpeting and rugs. Make localized application to the floor and baseboards. Spray directly into cracks, closets, and infested areas of shelving. Repeat if reinfestation occurs.

For Fleas: Clean premises thoroughly before treatment. Pet bedding should be cleaned or replaced with fresh bedding. Using a coarse cone or fan spray, the entire floor area should be treated with special attention to cracks, and crevices. Spray rugs (spot application only) including under edges. Treat animal sleeping quarters, closets, upholstered furniture (with particular attention to seams), and under sofas, beds, and other furniture where pets frequent. To avoid reinfestation, pets must be treated simultaneously, with an insecticide labelled for use on animals. Applications may be repeated if reinfestation occurs.

For Flies, Mosquitoes, Wasps and Small Flying Moths Outdoors: Do not use as a space spray. For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight of congregate.

For Ants Outdoors: For ants, thoroughly wet hills and runways. Repeat applications if reinfestation occurs.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with eyes, skin, clothing and avoid inhalation of vapours or spray mist. Wash thoroughly after handling and before eating, drinking, etc. Do not apply to plants, animals or humans. Remove pets and fishbowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact. DO NOT CONTAMINATE FOODSTUFFS. Do not use in any area where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboards where food or cooking utensils are stored. In homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before reuse.

FIRST AID: In case of poisoning, obtain medical attention immediately, taking the pesticide container with you. If on

skin, remove contaminated clothing and wash thoroughly with soap and water. If in eyes, flush with water for 5-10 minutes and obtain medical attention. If swallowed, give patient one to two glasses of water and induce vomiting. Repeat with water until vomit is clear. Do not cause vomiting if the patient is unconscious or in convulsive state.

TOXICOLOGICAL INFORMATION: Diazinon is a cholinesterase inhibitor. Atropine is antidotal.

DISPOSAL: Do not reuse container. Wrap and dispose of empty container with household garbage.
