DIRECTIONS FOR USE

Use clean (non-turbid) water for spraying. Applications made on cloudy days, during dull sunlight or just prior to or during periods of darkness, will generally increase the subsequent effectiveness of the treatment. To insure the success of a chemical summerfallow programme, winter annuals must be controlled with 2,4-D, MCPA or GLEAN(R) with a late fall (preferred) or early spring application in the fallow year. DO NOT APPLY BY AIR.

CHEMICAL SUMMERFALLOW: SWEEP is recommended for application only with ground sprayers. For control of emerged annual grasses on summerfallow, apply SWEEP at 1.7 to 2.25 L in 112 to 200 L of water per hectare when annual grasses are in the 2-4 leaf stage. Apply at 2.25 L per hectare under dry conditions or if weed population is very dense. Use 150 to 200L of water when weeds are in the 4 leaf stage. In most seasons, 2 applications will be required for annual grass control; one in late May or early June and another in late July or early August.

If broad-leaved weeds such as wild buckwheat or other hard to kill broad-leaved weeds are present at the time of application or between applications of SWEEP, apply one of the following SWEEP tank mixes, or a separate application of a broad-leaved weed herbicide registered for summerfallow use.

Tank Mixes: SWEEP may be tank mixed with GLEAN(R), 2,4-D, MCPA, bromoxynil plus MCPA, BANVEL(R) plus 2,4-D or LOROX(R) plus MCPA. Before tank mixing, consult labels of these herbicides for recommended rates, soil pH, cropping and rotation restrictions. GLEAN(R) and LOROX(R) L plus MCPA should only be applied once per season.

NOTE: Tank mixes of SWEEP with amine formulations of 2,4-D, MCPA and dicamba should be sprayed immediately and not allowed to stand overnight or the effectiveness of the spray will be reduced.
