GENERAL INFORMATION: A flowable micro-encapsulated formulation for effective knockdown and residual control of those pests listed below.

NOTE: This product is not intended for use in preparing oil-base sprays and must be diluted with water. BASUDIN FM will not cause disagreeable odours or damage paints, plastics, fabrics or other surfaces where water alone causes no damage. In compressed air sprayers use 50 mesh screens or coarser. Do not use 100 mesh screens. Do not store at temperatures below 0'C for convenient pouring.

DIRECTIONS FOR USE: Dilute BASUDIN FM to make a 0.25% to 1% active ingredient spray as indicated in the table below. Agitate sprayer occasionally to assure even coverage.

COCKROACHES:

For cleanout treatments apply BASUDIN FM as a 0.50 to 1% active ingredient concentration spray.

For maintenance treatments apply BASUDIN FM as a spot application 0.25% active ingredient concentration spray.

Apply as a coarse spray or with a paint brush to areas where cockroaches hide (e.g., cracks and crevices, baseboards, around waterpipes, surfaces behind and beneath cabinets, sinks, stoves, etc.). Treatment should be repeated as necessary.

ANTS, SILVERFISH, EARWIGS (Maintenance and clean-out treatments): Make spot applications of 0.5% to 1.0% active ingredient concentration spray. Apply as a coarse spray or with a paint brush to baseboards, areas around water pipes, cracks and crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves and similar areas where these insects hide. Treatments should be repeated as necessary.

For very heavy infestations make the first application at a strength of 1% active ingredient concentration spray and repeat as necessary at 0.5% strength spray application.

CARPET BEETLES:

Apply a 0.5% active ingredient concentration spray in spot applications along baseboards and along edges of carpeting, under carpeting and rugs and furniture, in closets and on shelving and wherever these insects are seen or suspected. Repeat as necessary.

SPIDERS:

Apply a 0.5% active ingredient concentration spray around windows, doors and along baseboards. Make spot applications to other areas over which these pests may crawl.

BROWN DOG TICKS, FLEAS IN BUILDINGS:

Make a thorough application of a 0.5% active ingredient concentration spray to infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation. Repeat application as infestations warrant.

CLOVER MITES IN BUILDINGS:

Apply a 0.5% active ingredient concentration spray to window and door frames and sills, to baseboards and floor space adjacent to them with particular attention to cracks and crevices. Apply as a spray or with a paint brush thoroughly wetting surfaces.

FLIES IN BUILDINGS: (calf and dairy barns, livestock pens, farm buildings, processing plants (food, non-food), storage areas (food, non-food)). Apply as a 1% active ingredient concentration in a 2% sugar solution. Spray to treat ceilings, walls, window frames, beams, posts, around lights and other areas where flies congregate. Repeat application as necessary.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Harmful if swallowed. Foods and utensils should be removed or covered before treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when the facility is not in operation. Do not spray on humans or household pets. Remove all animals, fish and birds before spraying. Do not store product near food or feed. In barns; remove animals before spraying and keep them out for at least four hours. Do not use in poultry houses or in milkhouses. Do not apply as a space treatment. Do not contaminate feed, feeding troughs, water, milk or milk handling equipment. In dairies; apply when not in operation. Thoroughly clean all milk utensils before resuming operations.

In meat packing and food processing plants, only spray when plant is not in operation. No exposed meat products, ingredients or packaging materials to be left in the room and cover food handling equipment. Any treated surface that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing.

FIRST AID: If swallowed, induce vomiting. Obtain prompt medical attention. If on skin - wash thoroughly with soap and water. If in eyes - flush with plenty of clear water and obtain medical attention.

TOXICOLOGICAL INFORMATION: Diazinon is a cholinesterase inhibitor. Atropine is antidotal (1-2 mg every 15 to 30 minutes, if necessary).

CONTAINER DISPOSAL: Do not re-use empty container. Dispose of empty container through normal waste disposal channels.

STORAGE: Avoid freezing. Do not store at temperatures below 0'C. Replace container cap tightly to avoid evaporation.
