Read the entire label for complete directions before using this product.

**DIRECTIONS:** For best results, clean machine sump and coolant system prior to use. Add coolant and water to the sump at the dilution favourable for the particular machining operation involved. Add 1 part (1 litre) of COOL SAVER for each 100 parts (100 litres) of diluted coolant solution in machine sump. After 6 weeks of operation, add an additional part (1 litre) of COOL SAVER for each 100 parts (100 litres) of diluted coolant solution in the sump.

In normal machining operations, coolant solutions should be drained and the sump thoroughly cleaned and recharged after each 12 weeks of operation.

### DISPOSAL

1. Triple- or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
5. For information on disposal of unused, unwanted product contact the

manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.**
