GENERAL INFORMATION

EARWIGS: Earwigs are brown, hard-shelled insects which have pincher-like appendages at the rear. These pinchers do not harm humans. Earwigs are nocturnal insects. They prefer dark damp areas. They feed on a variety of things such as flowers, leaves and vegetables. And they will also eat mites and the young stages of other insects. Food matter in homes is also attractive to them.

Earwigs overwinter as adults under rocks, logs, debris, in the soil, and around the foundation of the home. The female earwig lays her eggs in late winter to early spring brooding over them until they hatch. There are two generation of earwigs per year in most locations.

Control of earwigs is not simple. They are active insects and live in areas difficult to treat properly.

DIRECTION FOR USE

7.5 g = 1 level tablespoonful

OUTSIDE DWELLINGS: Soon after earwigs are first noticed, apply Earwig Killer Dust to the soil around the foundation of the home. Apply 500 g (full container) in 30cm band over a linear length of 40 m. Repeat the treatment when earwigs are again seen in the house or on the outside of the house. Make no more than 2 applications per season.

VEGETABLES: Apply dust to soil around plant at a rate of 70 g per 10 m of row. Use on broccoli, Brussels sprouts, cabbage, Chinese cabbage, cauliflower, carrots, celery, cucumbers, green peppers, onions, potatoes, sweet corn and tomatoes. Do not use on green bunching onions. Repeat as needed. Do not make more than nine applications during one season.

Soil Treatment: Dust turf or soil around plants to give even coverage. Apply 425 g per 10m2. Make no more than 2 applications per season.
