To control insects listed on front panel apply to cracks,  
crevices or as a spot treatment.

GENERAL DIRECTIONS:

KEEP CHILDREN AND PETS AWAY FROM TREATED SURFACE UNTIL DRY. To  
apply, hold container approximately 30 cm from surface being  
sprayed and spray until wet. Apply a thorough coating which will  
vaporize into cracks and crevices for insect control. Repeat  
applications as necessary when re-infestations occur. Use only as  
a surface spray. Ventilate treated area after indoor use.

INDOOR USE:

Spray thoroughly into crevices, cracks, and spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.

OUTDOOR USE:

Apply to the outside of screen frames, doors, window frames, foundations, patios, light fixtures, and other places where insects may alight, or congregate, and enter. Cluster flies and house flies will be killed if they land on treated surfaces.
