FOR SANITARY SWIMMING & WADING POOL WATER:

Add the correct amount of POOL-12 to the water daily.
POOL-12 is recommended for use in all types of pools: vinyl lined, concrete and fiberglass.

DIRECTIONS

Before adding POOL-12, the pH should be tested and adjusted to within 7. to 7.8. Add muriatic acid if pH is high. Add soda ash if pH is low.

POOL-12 should be added daily to maintain 0.5 to 1.0 parts per million available chlorine. The use of a test kit is recommended, as the air temperature and the number of people in the pool will affect the amount of POOL-12 required.

Under average conditions, POOL-12 should be added daily to pool water according to the following chlorination guide:

Pool Capacity (Litres)	Daily POOL-12 Charge (Litres)
30,000	0.6 L
50,000	1.0 L
80,000	1.6 L
100,000	2.0 L
200,000	5.0 L

Note: First application should be double the indicated amount. Every three weeks, add one week's charge of POOL-12 in one application to ensure proper control of algae, slime and fungus. Avoid using pool until chlorine residual drops below 2.0 p.p.m. (approximately 24 hrs.)
