DIRECTIONS

Water Chlorination: Add SUPER PRO daily to maintain .6-1.0 parts per million of available chlorine (PPM C1 2). Daily charge depends upon air temperature and number of people in the pool.

ALGAE: Add 375 mL of SUPER PRO for every 10,000 L of water and circulate for at least 8 hours. If algae persists, use a weak solution of muriatic acid and scrub walls with brush. Do not use pool until available chlorine has fallen to 2.0 P.P.M. CI2.

pH CONTROL: A pH of 7.2 to 7.6 is acceptable. Add muriatic acid if HIGH. Add soda ash if LOW.

WADING POOLS: Add 5 mL of SUPER PRO for every 250 L of water daily.
