Use on decks, window sashes, doors, garden furniture, fences and lumber in horticultural uses. Harmless to plants when dry. May be stained with Rez stains or painted.

DIRECTIONS: Wood surface must be clean, dry and bare before treatment is applied. Use as supplied. Do not thin. Apply liberally by brush or by immersing wood in liquid. 1. Immersion: For maximum effectiveness it is preferred over brush application. Soak for a minimum of 6 minutes per 2.6 cm of thickness. A soaking trough can be made using polyethylene sheeting. 2. Brushing: if dipping is impractical, brush a minimum of two generous coats. Allow the first application to dry before the second and subsequent coats. Allow the treated wood to dry thoroughly before staining or painting. To protect lumber, including pressure treated lumber, from cracking and splitting caused by moisture penetration, apply 1 or 2 coats of Rez

Watershield after application of Rez End Cut Preservative.

COVERAGE: Approximately 5 square metres per litre per coat.

CLEAN UP: Clean brushes and equipment with Polyclens or mineral spirits.

DISPOSAL: Do not dispose down drains. Use an approved household hazardous waste transfer facility.

CAUTION: Avoid skin contact. When applying, wear eye protection, plastic/rubber gloves and appropriate protective clothing. Harmful or fatal if swallowed or inhaled. Use only under well ventilated conditions. Do not spray. Keep out of reach of children. Keep preservative solution and wet wood away from animals, plants and grass, food, eating areas and feed products, heat, open flame or spark. Combustible. Do not use for treating wood in areas in contact with food or drinking water. Wash hands and contact areas thoroughly with soap and water after using.

FIRST AID TREATMENT: Contains petroleum distillate. If swallowed call physician or poison control centre immediately. Eye Contact: Flush with water for 16 minutes. Contact physician immediately. Skin Contact: Wash thoroughly with soap and water.
