Initial dosages of 25-75 ppm of Sternson 887 are recommended until control of micro-organisms is evident. Regular dosages of 6-40 ppm of Sternson 887 are recommended once biological control is established. Dosages may vary to suit individual plant requirements as recommended by a Sternson representative. Sternson 887 is normally slug fed to the sump of the cooling tower every 2 to 5 days.
