DIRECTIONS FOR USE:

Horses and Swine: Spray very lightly once daily, using a Livestock Sprayer

To Protect from Attack by Lice and Ticks: The animals should be sprayed at the rate of 56 mLs per spraying for one adult animal. Immediately rub the spray into the hair, paying particular attention to infested areas. Repeat as necessary, but not more frequently than once every three weeks. Ticks must be contacted directly with the spray.

To Protect from Attack by Face Flies: Apply to the faces of cattle at the rate of 28 mLs per animal, paying particular attention to the areas near the eyes and nostrils. Wipe on face with a heavy cloth or sponge. Avoid spraying directly into the animals eyes.

PRECAUTIONS: Flammable mixture. Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water, mineral supplements, or food stuffs. Do not contaminate milk or milk handling equipment with this spray. Do not use in milk processing plants or milk parlours. KEEP OUT OF REACH OF CHILDREN. Do not use near birds, fish or pets. This product is toxic to fish. Do not contaminate any body of water with this product. Avoid overspraying which will result in wetting the animals hide. Do not spray on plastic, or varnished surfaces. Mix well before use. Store in a cool place. Keep container tightly closed. Do not reuse container. Dispose of empty container in regular garbage.
