#### DIRECTION FOR USE

Prior to the use of CBT Biocide C in water cooling towers, systems should be cleaned to remove algae growth, microbiological slime and other deposits. Then make an initial slug addition of 380 - 800 ml of CBT Biocide C per 10,000 litres of water in the system. Repeat initial dosage until control is evident. Make subsequent slug additions of 380 - 800 ml of CBT Biocide C per 10,000 litres of water every 1 to 5 days or as needed. The frequency of addition depends on the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be make in the sump of cooling towers.
