VOLCK Supreme Spray is an especially refined Phytonomic Oil. Contact Insecticide. It is for use on plants in the dormant stage. When using this product in combination with other pesticides as directed on this label, observe appropriate cautions, limitations for the products involved.

For foliage applications, the spray tank must be free of any sulfur residue before using VOLCK Supreme Spray. Do Not combine sulfur sprays with VOLCK Supreme Spray on foliage and do not follow a previous application of sulfur or apply sulfur following VOLCK Supreme Spray until sufficient time has elapsed for safety (at least 30 days). If in doubt, spray a portion of one tree previously treated with sulfur, using 3.75 L to 100 L water. If sufficient time has not elapsed following treatment with sulfur, burn will show in several days. Do not use VOLCK Supreme Spray when temperatures are above 32°C. When temperatures drop below 0°C (usually nighttime lows), do not spray trees until daytime temperatures have warmed to a point above 2°C, and trees are free from moisture due to melting frost or heavy dews. Do not use on foliage closer than 60 days after or 90 days before using Captan or Folphet products. Do not use in combination with Carbaryl. Application to trees weakened by disease, drought, drying wind, or high nitrogen applications may result in oil injury.

APRICOTS, PRUNES: European Red Mite, Lecanium Scale, San Jose Scale. Apply 15-20 litres at dormant or delayed dormant stage.

CHERRIES, PEACHES, PLUMS: European Red Mite, Lecanium Scale, European Fruit Scale, San Jose Scale. Apply 15-20 litres at dormant or delayed dormant stage.

APPLES: Rust Mite. Apply 15-20 litres at delayed dormant stage.

APPLES, PEARS: European Red Mite, San Jose Scale. Apply 15-20 litres at dormant or delayed dormant stage.

FOR BRITISH COLUMBIA ONLY:

APPLES, PEARS: European Red Mite, San Jose Scale: Concentrate sprayers only, use 35-55 litres of product per hectare in 400-1,200 litres diluted spray per hectare. For applications of 2,500 litres or more diluted spray per hectare, apply 67 litres VOLCK Supreme Spray per hectare at dormant or delayed dormant stage.

PEARS: Pear Psylla, Blister Mite. Apply 20 litres at delayed dormant stage.

ORNAMENTALS AND SHADE TREES (Conifers - see note), Holly, Sycamores, Hawthorne, Cherry, Apple, Magnolia, Maple, Dog-wood, Oak, Privet, Birch: Soft Brown Scale, Oyster Shell Scale, San Jose Scale, European Red Mites (and Eggs). MIXING DIRECTIONS : With agitator running, start filling spray tank with water. when combining with Wettable Powder insecticide or fungicide products, add these first when tank is 1/3 filled. Add VOLCK Supreme Spray when tank is about 1/2 full and while there is sufficient agitation of the spray to insure complete emulsification.

Check this product for proper emulsification by mixing a small quantity of it with water in a small container before filling the entire spray tank. Correct emulsification is indicated when a uniform milk white spray mixture results while shaking. If the spray mixture is not milk white after shaking, do not use the remaining product.
