STORAGE & DISPOSAL:

1. PROHIBITIONS: Store in a cool, dry, ventilated place. Keep away from heat, fire and sparks. Do not contaminate any body of water, food, or feed by storage or disposal. Open dumping is prohibited.
2. DECONTAMINATION AND DISPOSAL: Decontaminate equipment and empty containers by thoroughly rinsing with water and dispose of rinsings by burying in non-crop land away from water supplies. Crush, break, or puncture empty containers and bury with the rinsings or deliver them to sanitary land-fill dumps in accordance with municipal requirements. GENERAL USE PRECAUTIONS:

READ THE ENTIRE LABEL BEFORE USING. Use only as recommended for claims listed.

During commercial seed treatment never handle material with bare hands. Use rubber gloves; do not use leather or cloth gloves. Avoid spilling on skin or clothing. Do not breathe spray mist. Wear a respirator and goggles or face shield while mixing, loading and spraying. Wash hands, face and arms thoroughly after handling captan and before eating, drinking or smoking. Shower after use or at the end of the work day.

When handling or applying, wear goggles or face shield and clothing that completely covers arms and legs to minimize exposure. Change contaminated clothing daily and wash thoroughly before re-use.

Always work out of the wind during mixing and loading operations. Keep unprotected persons out of operating area or vicinity where there may be drift. When treating, augering or handling treated seed, work in a well-ventilated area, and wear a respirator, gloves and goggles or face shield.

If an accident occurs, remove contaminated clothing and wash skin thoroughly with soap and water. Wash clothing and gloves before re-use.

FIRST AID: In case of poisoning, call a physician immediately.

IF ON SKIN: Remove contaminated clothing and wash skin thoroughly with soap and water.

IF IN EYES: Flush with water for 5 to 10 minutes and obtain medical attention.

IF SWALLOWED: Give the patient one or two glasses of water, and cause vomiting by giving one dose of syrup of ipecac. If the patient does not vomit within 20 minutes, give a second dosage.

If the syrup of ipecac is not available, give the patient one or two glasses of water and cause vomiting by inserting a finger down the throat. Repeat with water until vomit fluid is clear. The patient should be lying down with the head below the level of the feet. DO NOT TRY TO CAUSE VOMITING IF THE PATIENT IS UNCONSCIOUS OR IN A CONVULSIVE STATE.

DIRECTIONS FOR USE AND RECOMMENDATIONS: READ ALL DIRECTIONS BEFORE USING AND USE ONLY AS SPECIFIED ON THIS LABEL.

DIRECTIONS: Stir thoroughly to mix contents before using. Thoroughly mix the recommended amount of Flowable Captan Seed Protectant into the required amount of water for the slurry treater equipment and dilution rate to be used. Seed treated with a slurry should not be bagged or stacked until it has dried. Clean equipment thoroughly between treating operations.

PRODUCT INFORMATION: Flowable Captan Seed Protectant is a liquid suspension especially formulated for the treatment of seed prior to storage and planting to protect seed from molds and other fungi causing storage loss and to protect seed from seedborne and soil-borne fungi which cause seed decay, damping off, and seedling blights.
