APPLICATION INFORMATION:

"SECTROL" Pet Spray may be applied directly on to dogs and cats for treatment and control of cat fleas, dog fleas, American dog ticks and wood ticks.

Use areas: Residences, kennels, zoos

DIRECTIONS FOR USE

1. For best results, bathe and shampoo the pet with an insecticidal shampoo recommended by your veterinarian.
2. Rub off excess water with a towel. Your pet does not have to be thoroughly dried.
3. Adjust sprayer on bottle of "SECTROL" Pet Spray to deliver a coarse spray. Hold sprayer within a few inches of the haircoat.

Start by spraying your pet's head (avoiding contact with the eyes and mouth) and work your way back to the hind quarters. Spray under the haircoat by backcombing against the

direction of hair growth with your other hand. It is important to wet the entire haircoat and exposed skin thoroughly to assure adequate coverage.

4. Be sure to apply "SECTROL" Pet Spray between the toes and foot pads and any other areas where fleas may hide to avoid contact with the insecticide.
5. Allow your pet to dry. Do not towel dry as this will remove many of the "SECTROL" Pet Spray microcapsules. A blow dryer works well to shorten the drying time.

The microcapsules in "SECTROL" Pet Spray adhere to the haircoat and continuously release their active ingredients, thereby maintaining at least eight days residual activity.

6. If required, reapply "SECTROL" Pet Spray weekly.

In addition to treating your pet directly, control of fleas in your pet's environment is important if you wish to eliminate fleas from your home. Ask your veterinarian about "SECTROL" Premise Flea Spray (No. 1494) to help eliminate fleas from the carpeting, furniture, and other pet activity areas. When used as directed, "SECTROL" Premise Flea Spray provides up to 30 day residual control of fleas in the home.

LIMITATIONS: Do not apply to nursing females or to puppies or kittens under 8 weeks of age.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contact with eyes. Avoid breathing spray mist. Keep container closed when not in use. Cover or remove fish bowls and aquaria. Do not contaminate food utensils, feed or water. Wash hands after spraying and before eating or smoking. Do not use in nurseries or rooms where infants, ill or aged persons are confined.
