SANITIZING EQUIPMENT IN FOOD PROCESSING PLANTS

Clean and rinse equipment thoroughly.
Scrub with solution of 1.5 mL SUPERCIDAL per litre water.
Flush with potable water before re-use.
On surfaces difficult to clean (such as meat cutting
boards)
Increase strength of solution to 6 mL SUPERCIDAL per litre
water.

Rinse thoroughly with potable water.

MOLD CONTROL ON WALLS AND CEILINGS IN FOOD PLANTS

Clean surface thoroughly and rinse with potable water. Spray or sponge with solution containing 6 mL SUPERCIDAL per litre water. Repeat weekly or when new growth appears.

SANITIZING DAIRY EQUIPMENT - Clean and rinse equipment thoroughly. Immerse in solution of 1.5 mL SUPERCIDAL per litre water. Air-dry milk cans and other equipment. This solution is recommended for flank and udder washing prior to milking.

SANITIZING GLASSWARE, SILVERWARE, DISHES, COOKING UTENSILS, ETC. - Clean with suitable detergent, rinse thoroughly, then dip in solution of 1.5 mL SUPERCIDAL per litre water. Rinse in potable water and air dry. DO NOT USE A TOWEL. Solution effective in water containing 550 ppm. hardness.

GENERAL DISINFECTION AND SANITATION IN REST ROOMS - After cleaning and rinsings surfaces, apply a solution of 9 mL SUPERCIDAL per litre water. Allow to air dry. EXCELLENT DEODORIZER.
