DIRECTIONS FOR USE

Cunilate 2174-NO should be incorporated at levels of from 5% to 10% based on the volume of paint. The median level of 7.5% is most generally used and paints with this level of protection have been found to be completely free from mould after two years under conditions where ordinary paint became contaminated within 60 days.

Cunilate 2174-NO will impart a green colour to white paints. Slightly off whites are easily produced through titanium pigments. Reactive pigments should be avoided in formulations containing Cunilate 2174-NO. It will also usually be found necessary to incorporate additional driers since the drying time of the coating may be affected. Do not use on paper products or textiles that may come into contact with food or feed.
