DECONTAMINATION AND DISPOSAL: Do not reuse container; wash, perforate or crush and bury.

DIRECTIONS FOR USE: Honeybees: Place 15-30 mL of Calcium Cyanide Dust on a piece of paper and slide this paper in the hive entrance.

LIMITATIONS: Honey must be removed before bees are gassed.

NOTICE TO BUYER: Seller's guarantee shall be limited to the terms set out on the label and subject thereto, the buyer assumes the risk to persons or property arising from the use of handling of this product and accepts the product on that condition.

NOTICE TO USER: This control product is to be used only in accordance with the directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions.

NATURE OF RESTRICTION: This product is to be stored apart from lodging for humans, animal quarters, and normal work areas, to avoid inadvertent exposure.

FIRST AID: Start treatment immediately. Call a physician immediately. Carry patient to fresh air. Have him lie down. Remove contaminated clothing, but keep patient warm. If inhaled, break an amyl nitrite pearl in a cloth and hold lightly under nose for 15 seconds. Repeat 5 times at intervals of about 15 seconds. Use artificial respiration if breathing has stopped.

If swallowed, break an amyl nitrite pearl in a cloth and hold lightly under the nose for 15 seconds. If patient is conscious, or when consciousness returns, give an emetic and repeat until vomit fluid is clear. Repeat inhalation of amyl nitrite five times at intervals of about 15 seconds. Use artificial respiration if breathing has stopped. Never give anything by mouth to an unconscious patient.

PRECAUTIONS: Keep out of reach of children. Extremely toxic if swallowed, inhaled or absorbed through the skin. Store in a cool, dry, well-ventilated area. Keep container tightly closed. Do not breathe dust or gas. Do not handle with bare hands. Wash hands thoroughly after use. Always wear a gas mask equipped with an HCN canister. Flammable. May cause minor injury to roots of grasses and shrubs.
