Apply Atra-Pell dry from the container according to instructions below and spread it evenly. For best results, treated area should be watered lightly following application. Do not expect the granules to dissolve. Active ingredients will wash off leaving insoluble carrying agent on surface. Broadleaf weeds will begin to wilt within two days of application.

For control of annual and shallow-rooted perennial weeds, use 30 grams Atra-Pell per 10 sq. metres.

Use a hand-held granule spreader or similar equipment. Clean all application devices thoroughly after use.

Wear long-sleeved shirt, long pants, socks, shoes and chemical-resistant (e.g., rubber) gloves.

Rinse gloves before removal. Wash hands before eating, drinking, using tobacco or using the toilet. If pesticide penetrates clothing, remove immediately, then wash thoroughly and put on clean clothing. Remove clothing and launder separately, and promptly and thoroughly wash hands and exposed skin with soap and water, then shower. Re-use gloves for pesticide application only.

Do not store near feed or fertilizer. Heavy rains may wash granules down steep slopes. Do not apply where there is a risk of the chemicals spreading to lawns, crops, or penetrating to the roots of ornamentals. Avoid contact with eyes.

Dispose of container with household trash. Do not re-use container for any other purpose.

Do not allow people (other than applicator) or pets on the treatment area during application. Do not enter treated areas for at least 24 hours.

If swallowed, induce vomiting using finger to back of throat method. Bring patient to nearest hospital taking this labelled container with you or contact a poison control centre. In case of skin contact, remove contaminated clothing and wash skin with soap and water. If in eyes, flush with plenty of water for fifteen minutes and get medical attention.
