DIRECTIONS FOR USE:

SPACE SPRAY: Use full strength to kill horse flies, face flies, stable flies, horn flies, lice, ticks, house flies, mosquitoes and gnats. Remove all livestock from barn. Close barn and shut off all ventilating systems. Using a Micromister II to dispense as a fine mist, apply at a rate of 100 mL of spray per 100 m3 of room space. Direct mist upwards to all parts of the room especially windows and other light sources. Whenever possible, keep doors and windows closed for 30 minutes after each treatment. Also direct mist into areas where insects are present. Do not remain in treated areas. Spray only when temperature is under 32'C.

Ensure proper ventilation after sealed areas have been treated. Following ventilation, clean up dead insects.

PRECAUTIONS: Flammable mixture. Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water, mineral supplements, or food stuffs. Do not contaminate milk or milk handling equipment with this spray. Do not use in milk processing plants or milk parlours. KEEP OUT OF REACH OF CHILDREN. Do not use near birds, fish or pets. This product is toxic to fish. Do not contaminate any body of water with this product. Do not spray on plastic, or varnished surfaces. Mix well before use. Store in a cool place.
