DIRECTIONS FOR USE: SUNOCO CORN OIL CONCENTRATE is a superior type agricultural spray oil specifically formulated with a surfactant to be used with Atrazine sprays for post-emergency weed control applications in corn.

USE PRECAUTIONS: Care should be exercised when SUNOCO CORN OIL CONCENTRATE is applied to new varieties or highly inbred lines of corn not previously treated with spray tank adjuvants. It is highly recommended that small scale test areas be treated before undertaking full scale application. Caution is also recommended when sprays are applied under very hot (dry), humid conditions, cold weather, frost or under conditions which may enhance the activity of Atrazine. This risk of damage to other vegetation form spray drift is increased with the use of Atrazine in oil-water emulsions. Do not add any other herbicides or hormone type weed killers such as 2,4-D, 2,4-DB, MCPA, MCPB or Dicamba.

CORN (field, silage, seed and sweet): Use the recommended rate of Atrazine as given on the product label. Apply to emerged

broadleaf weeds and grasses before they are 4 cm high and before 24 days from the date of planting. Add 1.25 litres of SUNOCO CORN OIL CONCENTRATE per 100 litres of spray solution. Apply the spray solution at an application rate of 200 to 400 litres per hectare. Do not apply after the corn is 15 cm high.

MIXING INSTRUCTIONS: Fill the spray tank half full with water, add the desired amount of Atrazine and continue filling. Add SUNOCO CORN OIL CONCENTRATE last. After filling, continue agitation. CAUTION - Avoid violent agitation of the materials in the spray tank. Excessive agitation may produce an invert emulsion causing coagulation and settling of suspended materials.

WARNING: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid contact with skin, eyes, or clothing. Handle and apply only as directed and at recommended rates. Do not apply or allow to drift to areas occupied by plants, other than those being sprayed, or unprotected humans and animals. Do not contaminate water supplies, irrigation ditches, ponds lakes or streams.

FIRST AID: This product contains a petroleum distillate. If swallowed, DO NOT INDUCE VOMITING. Get medical attention immediately, or contact a Poison Control Centre. Follow provincial instructions for any required additional cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements.
