GlideRinse III is designed for use in hospitals, schools and other institutions where hard surface disinfection can aid in controlling cross-contamination.

DIRECTIONS FOR USE

## Disinfection

In Hospitals, Nursing Homes and Other Health Care Institutions -Add 8 ml of GlideRinse III per liter of water. In Institutions, Industry and Schools -Add 4 ml GlideRinse III per liter of water.

Apply GlideRinse III to previously cleaned floors, walls and other similar nonporous surfaces with a cloth, mop or mechanical spray device. Thoroughly wet all surfaces and allow to remain wet for 10 minutes.

## Sanitation

Food Equipment and Other Hard Nonporous Surfaces in Food Contact Locations-Wash and rinse all articles thoroughly, then apply GlideRinse III, 2 ml per liter of water (150 ppm active). Surfaces should remain wet for at least one minute followed be adequate draining and air drying. No potable water rinse is required.

GlideRinse III (2 ml/L of water) may be used to sanitize sink tops, counter tops, refrigerator storage and display equipment, dishes, silverware, glasses, cooking utensils and other similar food processing equipment. Sanitize the above equipment, utensils and surfaces by either immersion, cloth, brush or mechanical spray device. No potable water rinse is required.
