This insecticide is for use only in an automatic mister dispenser, (Cam Spring action type), which releases 55 mg every 15 minutes. The continuous use of this Insecticide will reduce the flying insect populations-the effect should be noticeable within a few hours. Each can contains enough product to protect a room of 170 cu. m for up to 30 days.

USE AREAS: Restaurants, Food Plants, Dairies, Stables, Cow Barns, Poultry Houses, Ski lodges, Summer Lodges, and Resorts and other areas with at least 170 cu. m of free flow air space where flies, mosquitoes and gnats are an annoyance.

DIRECTIONS: Dispenser must be located 2-3 metres above floor at point where air circulation will carry particles through the area. Do not install directly over food or food packaging surfaces. To install can, remove protective cap and insert into dispenser.

CAUTION: In meat and food processing plants, only apply when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after application and before re-use for food packaging.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Contents under pressure: Container may explode if heated. Do not expose to temperatures above 50 'C. Do not puncture or incinerate. Do not contaminate food, feed, or water. Do not spray over milk or milking equipment. Avoid contact with skin and inhalation of spray mist. Wash after using. Contents toxic to fish and birds. Do not install directly over polished, plastic or varnished surfaces. Do not use in nurseries or rooms where infants, ill or aged persons are confined.
