LONZA FORMULATION S-18F has been formulated to aid in the reduction of cross-contamination in the areas. LONZA FORMULATION S-18F is a one-step disinfectant-cleaner that is effective against a broad spectrum of bacteria, is virucidal, fungicidal and will prevent the growth of mold and mildew and their odors when used as directed. When used as directed. LONZA FORMULATION S-18F will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas and other places where bacterial growth can cause malodors.

DIRECTIONS FOR USE:

LONZA FORMULATION S-18F is a proven "one-step" disinfectant-cleaner-sanitizer-fungicide-mildewstat-virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply LONZA FORMULATION S-18F to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, or mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION - to disinfect hard, non-porous surfaces, add 8 mL/L of water. Treated surfaces must remain wet for 10 minutes. At this use level. LONZA FORMULATION S-18F is also virucidal and fungicidal. At this dilution, all surfaces on which this product is used and which come in contact with food, are to be rinsed with potable water. 8 mL/L Use-Level: The broad spectrum activity of LONZA FORMULATION S-18F has been evaluated and found to be effective against the following organisms by the AOAC Use-Dilution test:

SANITIZING - to sanitize pre-cleaned, non-porous food contact surfaces and utensils immerse in a 1.5 mL per 1 L (150 ppm) solution of S-18F for at least 60 seconds. Allow to air dry. Do not rinse. For equipment and utensils too large to sanitize by immersion, apply a 3.0 mL per 1 L solution of S-18F (300 ppm) by rinsing, squirting or swabbing until thoroughly wetted. Allow surface to drain and air dry. Do not rinse. Wash hands thoroughly with soap and water after handling.

AOAC Fungicidal Test: LONZA FORMULATION S-18F is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc.

Mold and Mildew Control - at 8 mL/L LONZA FORMULATION S-18F will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general cleaning instructions above). Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance: at 8 mL/L use-level, LONZA FORMULATION S-18F was evaluated and found to be effective against the Influenza A/Brazil Virus on inanimate environmental surfaces.

Sanitizing - Non-Food Contact Surfaces (such as floors, walls, tables, etc.): at 1.5 mL/L use-level, LONZA FORMULATION S-18F is an effective sanitizer against Staphylococcus aureus and Klebsiella pneumoniae on hard non-porous environmental surfaces.

Instructions for Cleaning and Decontaminating Against HIV-1 on Surfaces and Objects Soiled with Blood or Bodily Fluids: This product is effective against HIV-1 (Human Immunodeficiency Virus) in hard water up to 400 ppm (CaCO₃), and in the presence of organic soil (5% blood serum)

Personal Protection: When handling items soiled with blood or bodily fluids, wear disposable latex gloves, gowns, masks, and eye coverings. Cleaning Procedure: Thoroughly clean blood or bodily fluids from surfaces before applying "Formulation S-18F". Contact Time: To kill HIV-1, apply "Formulation S-18F" at 32 mL per for 4 Litres of water and allow surface to remain wet for 10 minutes. Disposal of Infectious Material: Blood and other bodily fluids should be disposed of according to provincial and federal regulations for infectious waste disposal.

PRECAUTIONS:

DISPOSAL:
