DIRECTIONS FOR USE:

Spray undiluted where weed growth is heavy and rainfall is relatively high. Also where longer residual control is desired in regions with a long growing season.

COVERAGE: 5 litre per 100 m²

FOR LIGHT APPLICATIONS: Mix 1 litre of herbicide to 1 litre of water.

METHOD OF APPLICATION:

Use weed killing shield No. 1085, adaptable to most conventional garden type pump sprayers. Use coarse spray for better results. A sprinkler type watering can also be very effective.

ATTENTION: Rinse equipment and containers immediately after use.

PRECAUTIONS: This material affects all types of vegetation. Do not use on lawns, crops, around trees and shrubs or on areas underlaid by the roots of desirable plants.

Avoid Contaminating feed or foodstuffs. Avoid eyes and skin contact. Wash hands after handling. Do not store near feeds, fertilizers, seeds. Destroy original container when empty. Store away from heat.
