DIRECTIONS FOR USE:

To be used only in the manufacture of a product which is registered under the *Fertilizers Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes and clothing. May cause severe eye irritation or injury. Do not contaminate food, feed or water supplies. This product may cause skin sensitization reactions in certain individuals.

Handling the concentrate (mixing and loading):

Wear long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes, and protective eye wear (face shield or safety glasses). Rinse gloves before removal. Coveralls or a chemical-resistant apron should also be worn when open pouring from containers greater than 5 L.

Handling the dilute spray solution (during repairing or cleaning equipment):

Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes. Rinse gloves before removal.

FIRST AID:

If poisoning is suspected, call a doctor or poison control centre immediately.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
